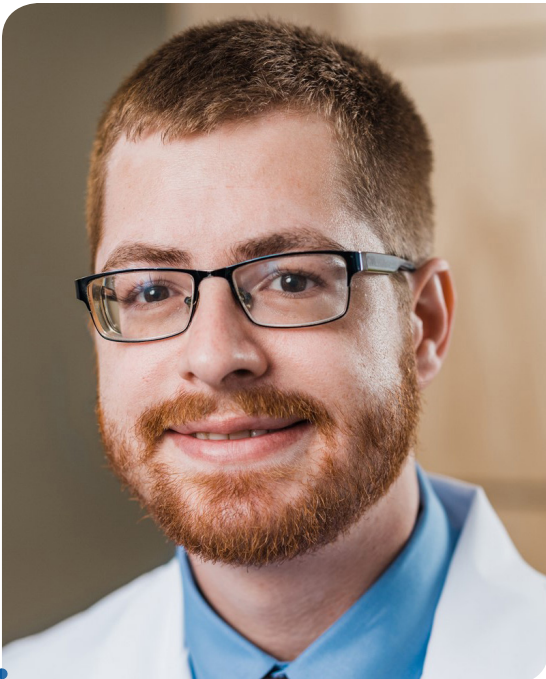

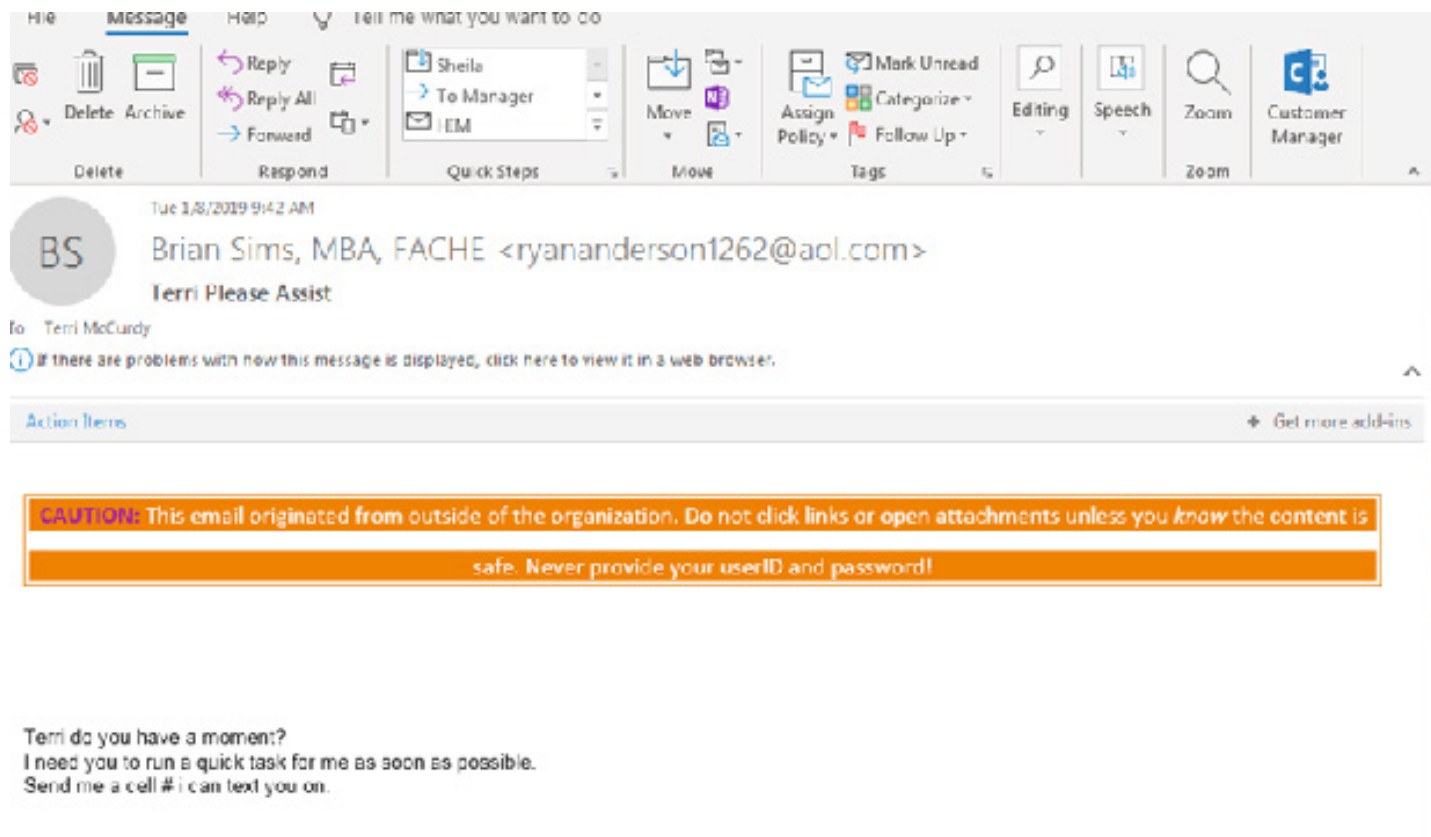

LCHC has been notified that some email recipients have received phishing emails like the one shown below. This type of request may be an attempt to intercept confidential passwords and/or codes that are sent to your cell phone.

If you have received a similar email and replied with your information, contact the IT Help Desk immediately at 855-294-6044. Otherwise, forward the message to help@wins.net and then delete it from your inbox.
