## Illness or Injury?

Before any employee (full time, part time, or PRN) may return to work, he/she must provide a physician's written release to Human Resources if they have been away for more than three consecutive shifts or received medical treatment with restrictions noted. Human Resources will review any restriction or accommodation with the employee's supervisor and make the appropriate decision regarding their return to work.

## LCHC Physical Therapy Now Offering Dry Needling

Those in pain now have one more option available through Functional Dry Needling therapy at Lucas County Health Center's Physical Therapy.

Dry Needling is a technique that uses a fine filament needle to deactivate or shut down painful or knotted areas in muscles. At LCHC, dry needling is offered to patients as an add-on to their physical therapy plan.

Pat Alt, Physical Therapist, trained through respected outlet Kinetacore to obtain his dry needling certification.

"Dry needling is fairly new to Iowa, but is growing," says Alt. "It is a great way to speed up the healing process and create better movement."

Dry needling is used to treat a variety of musculoskeletal issues including: neck, back, and shoulder pain; arm pain; tension headaches; knee and foot pain; buttock and leg pain; and more. At a cost of \$60 per session, it is an effective way for patients to enhance their therapy.

Alt has specialized training and certification in dry needling therapy. For the most effective treatment, this service is performed as part of a comprehensive rehabilitation plan rather than a standalone treatment.

## LCHC Hosts April Denim Days to Benefit Crisis Intervention

In 1992, an 18-year-old woman in Italy was picked up by her driving instructor to begin a lesson. Soon after, the instructor had her pull over to the side of the road and raped her. She pressed charges and won her case. The perpetrator appealed and the case went to the Italian High Court. In 1999, they overturned the conviction stating that since the victim wore tight jeans, the perpetrator would not have been able to remove them himself and, therefore, the victim must have willingly participated. Women of the Italian legislature protested the decision by wearing jeans. As news of the decision spread, so did the protest.

In April of 1999, California established the first Denim Day in the United States to challenge myths like this. The month of April has been designated as Sexual Assault Awareness Month in the United States. The goal is to raise public awareness about sexual violence and to educate communities and individuals on how to prevent sexual violence.

On April 12 and 26 LCHC employees are invited to wear jeans to raise awareness and funds for Sexual Assault. Employees can pay \$3 per day to wear jeans. Make payment in Marketing. All funds raised will benefit Crisis Intervention Services, which provides services in Lucas County.

Reporting packets are available from Human Resources, Supervisors and the Emergency Department

> REQUIRED Forward all documentation to Human Resources within 24 hours of incident!

Blood Borne Pathogen Exposures & Needle-Sticks

Immediately Report to the Emergency Department

LCHC reserves the **right to choose** the physicians and other medical providers who will furnish the employee's medical care.

### **Employee Instructions:**

- 1. Notify your supervisor and complete attached Report of Injury/Illness form in your own words immediately
- 2. Sign Workers compensation Benefit Overview keep a copy for your records
- 3. Check box waiving medical treatment at this time OR
  - A. Contact LCHC's Medical Clinic to receive medical treatment by an active medical staff member
  - B. Emergencies only Go to LCHC's outpatient desk and request to be seen by the medical provider on duty. Non-emergent should receive care in the clinic.

Note: Employees choosing a provider other than above does so at their own expense.

4. Return Release to Return to Work to Human Resources immediately

### **Supervisor Instructions:**

Inspect accident site immediately taking action to prevent similar injuries and complete supervisory sections on reverse of Report of Injury or Illness form.
