State of Iowa Employee Discount Program

U.S. Cellular

As an employee of LCHC, you may be eligible for a 10% discount on your U.S. Cellular plan. There are two ways to determine if you are eligible for this discount.

1. Go to a U.S. Cellular Store for assistance. You will need to verify employment with LCHC by showing them a recent pay stub or other proof of employment as well as provide them with reference discount code G2NRW.
2. Click the following link to register and receive more information. <http://www.perkspot.com> In the upper right hand corner, enter U.S. Cellular on the “find a great deal” tab to complete the process. You will need to use your LCHC email address. Employees without a LCHC email address must go to a U.S. Cellular Store.

Some of the things U.S. Cellular wants you to know:

- Customers not on Shared Connect Plus Plans must be on a plan with a monthly recurring charge of \$69.95 or higher for single line plans and \$99.95 or higher for Family Plans. Offer valid on Shared Connect Plans of 4GB and higher. Not valid on Data Only Shared Connect Plans.
- Discount will only be applied to the monthly data charge for your chosen plan. Discount not available on equipment or accessories. U.S. Cellular may require that you provide proof of employment. If you are no longer an employee of the eligible organization or if the organization is no longer a business customer of U.S. Cellular, U.S. Cellular reserves the right to remove any discount that has been applied to your account without notice.
- Customer must reapply, verify employment or verify program requirements every two years. All terms and conditions of the U.S. Cellular Customer Service Agreement apply to your participation in this program.
- The discount will be applied to your account within 1-3 billing cycles.

Snap Fitness Discounted Rates

Lucas County Health Center has a vested interest in keeping employees healthy and well. We have made arrangements with Snap Fitness – Chariton where you can have a discounted rate. They have offered to waive the \$10 key fee for all employees who enroll.

Fees for your membership to Snap Fitness through automatic bank withdraw are as follows:

Single Membership - \$37.40/month

Family Membership - \$55.59/month

To sign up for Snap Fitness, stop by Human Resources and complete a membership registration form. Memberships will begin at the first of each month.

LCHC Employee **In-State Hotel-Motel Discounts**

Iowa Department of Administrative Services **In-State Lodging Rate Agreement Program**

LCHC employees are eligible to take advantage of discounted rates at many in-state hotels as indicated below. If interested, we encourage you to:

1. Go to the courthouse and obtain the Iowa Department of Transportation Special Identification Authorization Form #431059
2. Complete the form by indicating you are a “county employee”
3. Ask Human Resources or your departmental manager to assign it as the “Authorizing Official”
4. Take the form to the Treasurer’s Office for processing. They will take your photo for processing and charge a fee of \$1.00.

Effective July 1, 2016 the properties included in the following lists have signed a rate agreement with the State of Iowa for the rates shown through June 30, 2017, subject to availability.

FY19 In-State Lodging – single room rate \$65 or less

FY19 In-State Lodging – other facilities

FY19 In-State Lodging Interactive Map (\$65 rate and other facilities)

Rate Extension: In addition to listing single room and double occupancy rates, the directory also notes whether state rates will be extended to political subdivisions (city or county governments, school districts, community colleges) or personal travel.

Rate Availability: All rates are subject to availability and employees are not required to stay at the properties listed. When inquiring for reservations and rates, be sure to specify State of Iowa rates, not Federal.

Employee ID: To receive the rate posted in the In-State Lodging Directory, please be prepared to show the photo ID you received from the treasurer’s office. You may also be required to show some other form of identification, whether an employee photo ID badge, LCHC paystub or similar documentation.
